- A. Elementary Principal Report Alex Meyers
  - 1. New Elementary Staff: if approved, positions will be filled at both schools.
  - 2. Cell phones: students shouldn't have cell phones out during instructional time. If they do, they are given the choice to put their phone in their backpack for the rest of the day or give it to the principal. Use of cell phones can't be tracked in restrooms. Superintendent Blaser and Principal Meyers will review the district policy on cell phone use in regards to the elementary school.
- B. Secondary Principal Report Tony Richard



- 1. Principal Goals Focus Overview: goals will be focused on strategic plan goal 3.3 and 3.4.
- 2. Discipline Data And Academic Performance Processes Overview: Discipline is a 3 step reporting process with mphasis on placing power of supervision with faculty.
- 3. Future Monthly Reporting Format: Monthly snapshot with IXL reporting for math and ELA and other academic data.
- 4. Athletics Meetings Overview: Working on guidelines for collaboration and communication with the community and students, will hold two recognitions for athletics one in the fall and one in the spring paired with academics, high visibility of administration at all games and events. Question about coach evaluations will it be in writing when evaluations are to be done rather than waiting to do all evaluations at the end of the school year.

# C. Superintendent Report - Jeff Blaser

- 1. Recruiting & Staffing Work: still looking for ½ SpEd, paras, bus drivers, and clerk of the board.
- 2. PreK Round up Update: about 22 students for the upcoming school year
- 3. District Grounds & Maintenance Projects: Update on various projects, including Crane Alarm's estimate for replacing the Rimrock fire alarm system. Estimate came in just under \$140,000. Due to the cost, we will be seeking another estimate for comparison.
- 4. District IT Update: reviewed projects Josh Rishell is working on to get things ready for the school year.
- 5. Transportation Update: Met with John and review policies regarding transportation.
- 6. Fiscal Update: expenditures year to date are at 5% but it is not concerning. The biggest expenditure contributing to this is paying out insurance.
  - i. Blue Cross follow-up: At the last meeting, trustees asked to look into the possibility of offering two insurance options. Two options can be offered. Reviewed the added costs to the the employee for the options.
- 7. ELT Offsite work: Review topics covered during the offsite meeting in July.
- 8. Policy Review: School districts are required to review certain policies annually. These policies needing annual review are list in policies 1303 and 4175 in the board packet. Need to update all the policy numbers in BGV polices as there are policies in 100s (3-digits) and others in 100os (4-digits). Also, accessing policies on the website should be easier. It takes about four clicks to get to the policy page.
- 9. ISBA convention in November is held in Coeur d'Alene this year, November 9-11. Any trustees interested in attending, notify Superintendent Blaser by October 1. Superintendent Blaser attended the IASA Conference.
