The math being implemented for the SY 19-20 will be monitored and evaluated with the assistance of CORELearn. The curriculum will be new to the district's elementaries so this research team will give tremendous insights into the purposes of implementing with fidelity, monitoring the routine work and evaluating the formative and summative work of the staff as resulting in student learning.
